Directions: This form must be accompanied by \$5.00 for each ID ordered. Checks must be made payable to **CAM**, and mailed to 9802 F.M. 1960 Bypass W., #210, Humble, TX 77338. You will receive your pool ID(s) by mail before the swim season begins. The Board of Trustees of the Atascocita South C.I.A. has specified that: (1) IDs may only be issued to property owners whose maintenance fees are current; (2) failure of a swimmer to follow the posted rules will result in revocation of pool IDs; and (3) the ID wrist bands must be worn at all times when the ID holder is inside the pool fence.

During most hours when the pool is closed to the public, the pool may be rented by members of the Association for private parties (advance payment for lifeguards and deposit is required).

About the Pool ID Distribution Process

Dear Residents,

As you may recall, pool IDs are annually renewing, available only to Atascocita South residents who wish to use the community pool. In order to receive pool IDs, maintenance fees for the property where you live must be current. The pool ID fee is separate from your annual assessment.

All pool IDs will be distributed from the Association's office. They will be available at the pool *one day only*, that day being May 2nd, 10:00 a.m. to 2:00 p.m., the day of pool opening for the 2009 swim season.

Using the pool ID form, you may order your IDs by mail, and the IDs will be mailed to you. After April 21, you may also pick up your IDs in the Association's office, 9802 F.M. 1960 Bypass W., Ste. 210, Humble, TX 77338, 8:30 a.m. to 5:30 p.m. They will not be available for purchase evenings or weekends.

The Board is confident that if all owners follow these guidelines, it will be a bit easier for all to begin enjoying Atascocita South's beautiful facilities again this swim season.
